STUDENT'S RIGHT TO CANCEL

The student has the right to cancel the enrollment agreement and obtain a refund of charges paid through attendance at the first class session (), or the seventh day after () enrollment (, whichever is later. The notice of cancellation shall be in writing and submitted directly to the Admissions Office, a withdrawal may be initiated by the student's written notice or by the institution due to student's academics or conduct, including, but not necessarily limited to, a student's lack of attendance. A registration fee of § 75.00 is a non-refundable item. Equipment, books, supplies, tools, uniforms, kits and any other items issued and received by the student would not be returnable after the cancellation period. After the cancellation period the equipment, supplies, textbooks, and uniforms Once received by the student it will belong to the student and will represent a liability to the student.

REFUNDS: A pro rata refund pursuant to section 94919(c) or 94920(d) or 94927 of the Code shall be no less than the total amount owed by the student for the portion of the education program provided subtracted from the amount paid by he student, calculated as follow:

Except as provided herein, all amount that the student has paid shall be subject to refund unless the enrollment agreement and the refund policy outlined in the catalog specify amount paid for an application fee or deposit not more than \$250.00, book, supplies or equipment, and specify whether and under what circumstances those amounts are non-refundable. Except when an institution provides a 100% refundable pursuant to section 94919(d) or section 94920(b) of the Code, any assessment paid pursuant to section 94923 of the code is non-refundable

If you cancel the agreement the school will refund any money that you paid, less any deduction for registration fee and equipment received. If you withdraw from school after the cancellation period, the refund calculation will included the hours you have completed and hours absent. If the amount that you owe is more than the amount that you have already paid, then you will have to arrange with the institution to pay that balance.
